As per the letter read (1) above, the Chief Engineer (Bridges) has submitted an estimate for Rs.30.80 lakh for the Reconstruction of Puthamon Bridge at Ranni Constituency in Pathanamthitta District -**Construction of Diversion Road** for ₹30.80 lakh.

2) The name of the work included in the proposal of Chief Engineer (Bridges) has mistakenly taken as 'Reconstruction of Puthamon Bridge ' instead of '**Construction of Diversion Road** ' and orders issued vide G.O. read above.

3) As per the letter read as 3^d paper above, the Chief Engineer (Bridges) has requested to correct the name of work as "Reconstruction of Puthamon Bridge at Ranni constituency in Pathanamthitta District-Construction of Diversion Road".

The bridge is located on Melookkara-Ranni Road (MDR) at Puthamon Junction.
