ORDER

As per the letter read as 1st paper above, Govt of India had conveyed the Administrative Approval for implementation of Biogas Programme under the Umbrella scheme of National Bio Energy Programme from FY 2021-22 to 2025-26 . The allocated budget of Rs. 100 crores for Biogas Programme includes the committed liabilities upto 31st March 2021 under the erstwhile Biogas Programme including NNBOMP. The scheme is implemented through Central Nodal Agency (CNA) system newly introduced in PFMS wherein Sardar Swaran Singh National Institute of Bio Energy, Kapurthala is designated as CNA and Director of Agriculture as a Child Agency. Director of Agriculture has informed that Child Agency Account is opened in ICICI bank and Approvals from the CNA in the PFMS portal has been completed and mapped. The assistance is released in real time by the CNA. The subsidy will be drawn from Government of India to the Child Agency, as and when claim arise based on clearly defined drawing limits. As this is a new System of Expenditure with new assistance rates, the Director of Agriculture has requested Sanction for implementation of Biogas

Programme through CNA system during 2023-24 to 2025-26 .

2. Government have examined the matter and are pleased to accord sanction to the Director of Agriculture for implementing the Biogas Programme under the Umbrella scheme of National Bio Energy Programme (Phase-I) through CNA system during 2023-24 to 2025-26 in the State.

3. The PIA is instructed to chalk out the plan of implementation and review the progress of implementation of the same in the State and send the updated monthly progress status report to MNRE (Biogas Division), regularly.
