#### **ORDER**

As per the Government Order read 1<sup>st</sup> above, sanction was accorded for the continuance of temporary posts in the Kerala State Insurance Department for a period of one year from 01/03/2023. As all these posts are essential for the smooth functioning of Kerala State Insurance Department, the request of the Director of Insurance vide letter read 2<sup>nd</sup> to convert all temporary posts in the Department as permanent posts has been forwarded to P & AR Department for work study. Now the Director of Insurance in his letter read 3<sup>rd</sup> above has requested Government to accord continuance sanction of temporary posts in the Kerala State Insurance Department for a period of one year from 01/03/2024.

Government after having examined the matter in detail are pleased to accord continuance sanction for the following 259 posts (74 posts in the Directorate of Insurance and 185 posts in the District Insurance Offices) for a further period of one year from 01/03/2024 to 28/02/2025.
