ORDER

As per the Government order read as 1st paper above, Government have implemented a project named "Operation Breakthrough" for urban flood mitigation in Kochi city. As per the 2nd paper above an amount of Rs. 4.5 Crore has been released for the work "OBT-Mitigation of flooding near High court junction and revamping of connected drains in Kochi Corporation" from the head of account 2245-07-101-99 NV SDMF structural Mitigation Measures SDMF. As per the 3rd paper above, District Collector, Ernakulam (Chairman of District Disaster Management Authority) has issued Administrative Sanction for the said work. As per the interim order read as 4th paper above, the Hon'ble High Court have directed to take urgent action in the vital components

included in the flood mitigation works.

Based on the decision of Technical Sub Committee meeting held on 28/05/2024, the Chief Engineer, Irrigation & Administration submitted revised DPR of the work "Mitigation of flooding near High court junction and revamping of connected drains in Kochi Corporation" as per 5th paper above.

The above revised DPR was considered by the Technical Sub Committee under SEC in its meeting held on 09/07/2024 and decided to issue Technical Sanction for the work "Mitigation of flooding near High court junction and revamping of connected drains in Kochi Corporation" for an amount of Rs.4.5 Crore(Rupees Four Crores and 50 lakhs only) as per the minutes read as 6th paper above.

In the above circumstances, Technical sanction is accorded for the work "Mitigation of flooding near High court junction and revamping of connected drains in Kochi Corporation" for an amount of Rs.4.5 Crore(Rupees Four crore fifty lakhs only) as per the DPR read as 5th paper above.

Chief Engineer, Irrigation & Administration shall make necessary arrangements to implement the work immediately and to submit the progress report of the work to the Government on a regular basis particularly at each stage and to pass the final bill only after quality control check.
