ORDER

As per reference(1), an amount of Rs.100000/-has been withheld from DCRG of Sri. Satheesan. K. Under Secretary, General Administration Department who expired while in service on 10/11/2008. He has availed HBA of Rs.65000/-bearing broadsheet No.AG44018, while officiating as Assistant in Information & Public Relations Department . Vide 4th paper above, Smt. Sreekumari S.N., W/o Late Satheesan.K. has requested to waive off and settle liability of her husband from DCRG and to disburse eligible amount.

As per letter read as 6th paper above, the Accountant General had intimated that a total liability of **Rs.1,32,508/-** (Principal Rs. 66,500/- + Interest 53,712+Penal Interest Rs.12,296/-) found in HBA

account , wherein an amount of Rs. 57,050/- has been credited by loanee. Thus balance of Rs.75,458/- (Principal Rs.9450/-+Interest 53,712/- + Penal Interest Rs.12,296/-) is outstanding in HBA account.

Government have examined the matter in detail and are pleased to **write off** the balance in principal amount of HBA amounting **Rs.9,450/-** (Rupees Nine Thousand Four Hundred and Fifty only) to show expenditure under head 2075-00-795-98-HBA write off(N/V) and credit under head 7610-00-201-98-HBA-State Service Officers (N/V) and to **waive** an amount of Rs. **53,712/-** (Rupees Fifty Three Thousand Seven Hundred and Twelve only ,on account of interest) in HBA availed by Satheesan. K., Under Secretary, GAD who expired while in service on 10.11.2008.

An amount of Rs.**12,296/-** (Twelve Thousand Two Hundred and Ninety Six only) under Penal Interest may be deducted from DCRG under the head of account **0049-04-118-99-interest on HBA** as per existing rules and regulations and balance amount may be disbursed.
