ORDER

As per the letter read as 3rd paper above, the Director (Generation - Electrical, REES, Soura, Nilavu, Sports & Welfare), KSEBL has intimated that Vahni Green Technologies has requested for empaneling the vendors who are already empaneled in KSEBL after remitting the prescribed Performance Bank Guarantee (PBG) to Thrissur Corporation, under the MNRE simplified procedure of Rooftop Solar Programme Phase – II. KSEBL also informed that presently under the MNRE simplified procedure of Rooftop Solar program Phase-II, the state utility viz KSEBL is collecting PBG of Rupees 2.5 Lakhs and further empaneling the vendors as per the Office Memorandum of MNRE, GoI read as 1st paper above. As of now 596 numbers of vendors are empaneled under the simplified procedure of Rooftop Solar Program by KSEBL after collecting the PBG and other required documents in the prescribed format. Consumers registering under DISCOM (KSEBL) can select vendors from the empaneled list, as these vendors are empaneled by

KSEBL. These empaneled vendors are obligated to remit the PBG to other licensees, such as Thrissur Corporation under the jurisdiction of the Kerala state for getting them empaneled.

2. As per the Office Memorandum read as 2nd paper above, the State Government

can authorize a specific DISCOM /a separate agency of the state to collect the PBG from

the vendors on behalf of other DISCOMs/licensees. To facilitate the implementation of

this memorandum, Director, (Generation-Electrical, REES, SOURA, NILAVU, SPORTS

&WELFARE), KSEBL requested to authorize KSEBL to collect the PBG from Vendors on

behalf of other DISCOMs or licensees and to permit KSEBL to provide the list of

empaneled vendors to other DISCOMs/licensees for uploading the same on their

respective National Portal accounts.

3. Government have examined the matter in detail and are pleased to authorize

KSEBL as the State Nodal Agency (SNA) for collecting the Performance Bank

Guarantee (PBG) from the vendors on behalf of all DISCOMS / licensees within the State

to complete the empaneling process of Rooftop Solar Programme Phase II vide Office

Memmorandum read as 2nd paper above. KSEBL is also permitted to provide the list of

empaneled vendors to other DISCOMs/licensees for uploading the same on their

respective National Portal accounts.
