**ORDER**

Government have issued Order read as 3rd paper above releasing an amount of ₹7,51,70,408/- out of which ₹7,48,69,089/- (Rupees Seven crore Forty eight lakh Sixty nine thousand and Eighty nine only) was to be released to Special Tahsildar LAG 1, Palakkad through STSB Account No. 714011400000444 for disbursement of compensation to the land owners in connection with the construction of Pugalur-Thrissur transmission Line. However, the software do not permit processing of bills of plan fund through STSB Account and the Special Tahsilar LAG 1 is not entitled to open a PSTSB Account.

2) Government have examined the situation in detail and has decided to release the amount through the PSTSB Account Number 799012700001418 of Kerala State Electricity Board Limited. KSEBL is directed to transfer the amount to the bank account of Special Tahsildar in charge of disbursement of compensation to the land owners in connection with the construction of Pugalur-Thrissur transmission Line immediately after the amount is credited to their PSTSB Account. After effecting transfer, a compliance report in this regard shall be furnished to Government.

3) The Government Order read as 3rd paper above is modified to this extent only.
