ORDER

As per the letter read as 1 st paper above the Principal Secretary to Government, Industries & Norka department, had intimated that the State Government has decided to participate in the 12th edition of the Annual Investment Meeting (AIM Global 2023) scheduled from 08 - 10 May 2023 at the Abu Dhabi National Exhibition Centre jointly by the Department of Industries, IT and Tourism.

2. Consequently, as per item 2 of the 2 nd paper read above it was decided

that 'the sponsorship amount of approx. \$150,000/-+5% GST (₹1.30 Cr) will be shared equally by all the three departments - Industries, IT and Tourism and that KSIDC shall release the payments to AIM initially and the departments of IT and Tourism will reimburse their share to KSIDC'.

- 3. The Managing Director, Kerala State Industrial Development Corporation as per letter read as 3 rd paper above has requested to release an amount of ₹ 75,94,141/- (Rupees Seventy Five Lakh Ninety Four Thousand One Hundred and Forty One Only), being the contribution of Department of Tourism towards the total expenditure of ₹ 2,27,82,423/- (Two Crore Twenty Seven Lakh Eighty Two Thousand Four Hundred and Twenty Three Only), incurred for the conduct of AIM Global 2023, held at Abu Dhabi, UAE (1/3 of the total expense), and to transfer the said amount to the bank account of KSIDC.
- 4.The Director, Tourism as per letter read as 4 th paper above has recommended to meet the expenditure in this regard from the Head of Account 3452-80-104-98-00-34-03-PV-Marketing (PV).
- 5. Government have examined the matter in detail and are pleased to accord sanction to the Director of Tourism to expend an amount of ₹ 75,94,141/- (Rupees Seventy Five Lakh Ninety Four Thousand One Hundred and Forty One Only), being the one-third contribution of the Department of Tourism towards the total expenditure of ₹ 2,27,82,423/- incurred for the conduct of 12 th edition of the Annual Invest Meeting (AIM Global 2023) , held at Abu Dhabhi, UAE, and to transfer the said amount to the bank account (Account No: 57047022188, State Bank of India(SBI), Kowdiar Branch) of Kerala State Industrial Development Corporation Limited.
- 6. The Managing Director, Kerala State Industrial Development Corporation shall furnish a Utilization Certificate to the Director of Tourism within three months of receiving the sanctioned amount and the Director of Tourism shall verify the authenticity of the Utilisation Certificate.
