In the circumstances, as proposed by the Commissioner of State Tax vide letter read as 3rd paper above, Government are pleased to order to grant permission to the Commissioner of State Tax to issue a vacancy circular inviting application for the recruitment of Technical Member (State). It is also ordered

that, the Deputy Commissioner, Policy Wing, GST Commissionerate is appointed as the Nodal Officer to interact with Central Government regarding infrastructure and other issues related to setting up of the State Bench of the Goods and Services Tax Appellate Tribunal.
