ORDER

As per the G.O read as 1st above, Government accorded sanction among other things, for the construction of Unity Mall in Phase IV Campus of Technopark at Pallippuram, Thiruvananthapuram. The Kerala Industrial Infrastructure Development Corporation (KINFRA) was entrusted therein as the Implementation Agency of the Unity Mall project. As per Office Memorandum read as 2nd above, the Department of Expenditure, Ministry of Finance, Government of India, the competent authority, on the recommendations of DPIIT for the State of Kerala, approved the capital expenditure amounting to Rs.120 Crore for the construction of Unity Mall at Thiruvananthapuram, Kerala, under Part-VI of the 'Scheme of Special Assistance to States for Capital Investment 2023-24'. And an amount of Rs.60 Crore (50% of Rs.120 Crore approved under Part-VI of the Scheme for 2023-24) was reallocated from the unspent amount of Rs.971.52 Crore available with the State Government of Kerala under the Scheme of Special Assistance to States for Capital Investment for 2022-23.

2) Subsequently as per GO read as 4th above, the Finance

Department authorised additional expenditure to the tune of Rs.60 Crore (Rupees Sixty Crore only) for the construction of Unity Mall at Thiruvananthapuram under the Scheme of Special Assistance as loan from Government of India for capital expenditure. The amount was authorised under the Head of Account 4851-102-86-01-Unity Mall (PV) which was newly opened as per Order read as 3rd above, for the distinct classification of the expenditure relating to the construction of Unity Mall.

- 3) The Managing Director, KINFRA as per letter read as 6th above has informed that a project specific Single Nodal Bank Account (A/c No.7729800668, IFS Code IDIB000T056) in Indian Bank Thiruvananthapuram Branch) has been opened by Kinfra for linking the project in PFMS and requested Government to release funds to the tune of Rs.60 Crore from the Head of Account 4851-102-86-01-Unity Mall (PV) to the above Bank Account.
- 4) Government have examined the matter in view of the Orders read as 3rd and 4th above and the concurrence of the Finance Department conveyed as per file read as 5th above in releasing the amount and are pleased to release Rs.60 Crore (Rupees Sixty Crore only) from the Head of Account 4851-102-86-01- Unity Mall (PV) to the Bank Account No.7729800668 (IFS Code IDIB000T056) of KINFRA maintained with the Thiruvananthapuram Branch of Indian Bank.
