## <u>ORDER</u>

As per Government order read as 4 <sup>th</sup> paper above Government have accorded sanction for the recruitment to the posts of Hazard Analyst (Forestry) (1 vacancy), Field Assistant (Electronics) (1 vacancy) and GIS Specialist (1 vacancy) through Centre for Management Development.

As per the letter read as 5<sup>th</sup> paper above, Commissioner, Disaster Management has informed that suitable candidates could not be identified for the above posts and has requested to consider permitting KSDMA to recruit to these positions by reducing the qualifications/experience criteria. As per letter read as 6<sup>th</sup> paper above, Member Secretary, KSDMA has requested to reduce the qualification for the posts of Hazard Analyst (Forestry), Field Assistant (Electronics) as follows.

- Hazard Analyst (Forestry) Experience requirement may be reduced from 1 year to Fresher and pass mark of 70% may be reduced to 60%
- Field Assistant (Electronics) Experience requirement of 2 years may be reduced to Fresher.
- Qualifications for the post of GIS Specialist need not be changed.

Government have examined the matter in detail and are pleased to revise the qualifications for the posts of Hazard Analyst (Forestry) and Field Assistant

(Electronics) as mentioned above. Commissioner, Disaster Management shall renotify the above vacancies in all leading newspapers with revised qualifications.
