## **ORDER**

As per Government Order read as 1st paper, sanction was accorded for the recruitment to various posts on contract basis in KSDMA for the conduct of the LSG DM Plan preparation in all LSGs as part of the "Nammal Namukkayi Campaign" under RKI. The posts were supported financially from Rebuild Kerala Initiative for one year from the date of joining of the recruited staff. Recruitment of Administrative Staff such as Accountants and Multi Tasking Officers (MTOs) were conducted through Kudumbasree.

Sri Govind T Babu, Accountant I, Sri Deepak Madhu, Accountant II and Smt Athira V.M, MTO-I joined service on 09/11/2020 and Sri. Sainul Abid K T, MTO II joined service on 10.11.2020. Vide GO read as 2nd and 3rd papers above, the contract of these staff were extended for one year respectively, with a one day break each time. Accordingly the contract period of Sri Govind T Babu, Accountant I, Sri Deepak Madhu, Accountant II and Smt Athira V.M, MTO-I ended on 10/11/2023 and that of Sri. Sainul Abid K T, MTO II ended on 13/11/2023. As per the letter read as 4th paper above, Commissioner, Disaster Management has requested to extend their contract period for one more year.

Government have examined the matter in detail and are pleased to extend the contract service period of Sri Govind T Babu, Accountant I, Sri Deepak Madhu, Accountant II, Smt Athira V.M, MTO-I and Sri. Sainul Abid K T, MTO-II in KSDMA for a period of one year from 30.11.2023 to 29.11.2024, as part of the "Nammal Namukkayi Campaign" under RKI, subject to the condition that if the project needs any posts further, fresh candidates should be engaged through Employment Exchange or through any transparent method with the approval of

the Government.
