## **ORDER**

As per the Order read 1 st paper above, Government have accorded Administrative Sanction for Kozhikode City Road Improvement Project (KCRIP)Phase I at an estimated cost of Rs.254.32crore, on BOT -Annuity mode, without tolling. Subsequently, as per the Order read 2 nd paper above, an amount of Rs.234.50crore was allocated for the land acquisition of 4.70178hec of land, in connection with the road work of Mananchira- Vellimadukunnu road, as a part of KCRIP and also as per the Order read 3 rd paper above, Government revised the Administrative Sanction for KCRIP Phase I(B)-Mananchira - Vellimadukkunnu Road for an amount of Rs. 131.21crore, under the h/a 5054-04-337-80-(P).

2. The Chief Executive Officer, KRFB as per the letter read above informed that the Government Order read 3<sup>rd</sup> paper includes only 12% GST and therefore
