## <u>ORDER</u>

As per the Government Order read above, in Principle Administrative Sanction was accorded for implementing Kollam City Road Improvement Project on DBFOT- Annuity mode at an estimated cost of Rs.365.34 Crore(Rupees Three Hundred and Sixty Five Crore Thirty Four Lakh only) based on DSR-2018, under the head of account 3054-80-800-92-10(P), subject to some conditions.

2. As per the letters read above, the Chief Executive Officer, KRFB submitted a revised proposal for sanctioning Rs.435,65,03,647/-Crore for the Land Acquisition and a Contingency charge of Rs.50,00,000/- for implementing the Kollam City Road Improvement Project.

3. Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for land acquisition of Kollam City Road Improvement Project as detailed below at an estimated cost of Rs.435,65,03,647/-(Rupees Four Hundred and Thirty Five Crore Sixty Five Lakh Three Thousand Six Hundred and Forty Seven only) under the head of account 3054-80-800-92-10(P). An amount of Rs.50,00,000/-( Fifty Lakh ) is also sanctioned as Contingency Charge under head of account "8443-00-117-99 Work Deposit" ( DDO Code 030561 B001) for the above project.
