Administrative Sanction was accorded for the work Improvements to Thrikkariyoor - Vadakkumbhagam Road from Ch. 0/000 to 5/300 km and Kothamangalam New Bypass road from Ch. 1/855 to 3/055 km in Kothamangalam LAC for an estimated cost of Rs. 1000 lakhs under the H/A 5054-04-337-99 vide Government Order read as 1st paper above.

2. The Chief Engineer, PWD Roads Division , Thiruvananthapuram vide letter read as 2nd paper above has requested to accord Revised Administrative Sanction for the above work for an estimate cost of Rs1000 Lakh under the H/A 5054-04-337-99 in Kothamangalam LAC

Government have examined the matter in detail and are pleased to accord Revised Administrative Sanction for the work "Improvements to Thrikkariyoor - Vadakkumbhagam Road from Ch. 0/000 to 5/300 km and Kothamangalam New Bypass road from Ch. 1/855 to 3/055 km" in Kothamangalam LAC for an estimate cost of Rs 1000 Lakh(Rupees Ten Crore only) under the H/A 5054-04-337-99 subject to the condition that hindrance free right of way should be ensured for entire reach of road before inviting tenders and mentioning the fact that re-construction of a culvert with a span of 6m across the Canal in chainage is excluded from the scope of work.
