ORDER

As per the Govt.Orders read 1st and 2nd papers above, Govt. have fixed the rate of restoration charges for road cutting, in connection with the Gas Pipe Line Scheme in Ernakulam District. Subsequently as per the Order read 3rd paper above, it is ordered that the Concessionaire shall have the option to carry out the restoration on their own under the supervision of Engineers of PWD.

2. The Petroleum and Natural Gas Regulatory Board (PNGRB), as per the letter read 5th paper above has granted Authorization (GoA) to

M/s.Sholagasco Pvt. Ltd. for laying, building, operating or expanding City Gas Distribution (CGD) network in Geographical Areas of Idukki, Kottayam & Pathanamthitta Districts. Accordingly, as per request of Sholagasco, the Chief Engineer, Roads has submitted proposal for granting permission for laying of Natural Gas Pipeline along PWD Roads.

3. Government have examined the matter in detail and sanction is accorded for granting road cutting permission to M/s.Sholagasco Pvt. Ltd. for laying Natural Gas Pipeline along PWD Roads, as a part of laying, building, operating or expanding City Gas Distribution(CGD) network in GA-11.21 Idukki, Kottayam and Pathanamthitta districts in the State in line with the existing guidelines and circulars. The restoration has to be carried out strictly as per specifications, existing guidelines and timelines and also under the departmental supervision.
