**ORDER**

As per letter read as 1<sup>st</sup> paper above the Commissioner of State Tax has submitted a proposal for executing an MoU between NACIN Cochin and the State Goods and Service Tax Department for joint training programme and a draft Memorandum of Understanding (MoU) was submitted for consideration and approval.

2) The National Academy of Customs, Indirect Taxes and Narcotics (NACIN) Faridabad, is the training institute of the Central Board of Indirect Taxes and Customs (CBIC) and its primary objective is to train tax officials to enhance the knowledge and skills which are essential for an efficient tax administration. The NACIN Cochin Zonal Campus is responsible for conducting various training programmes on topics such as GST, Central Excise, Customs, Narcotics and allied Acts.

3) The Commissioner of State Tax has reported that collaborative training between NACIN, Cochin and Kerala State GST Department will improve the

efficiency and productivity of tax officials, thereby increasing the state revenue, enhancing plugging revenue leakage and strengthening enforcement measures through joint training and knowledge sharing, and it is necessary to establish a formal framework for joint training program between NACIN Cochin and Kerala State GST Department.
