## **ORDER**

As per order read as 1 st paper above, Smt Leni A., Assistant Public Prosecutor (Senior Grade) was appointed on deputation basis as Assistant Legal Advisor, Crime Branch, Thiruvananthapuram Range Office and accordingly she was relieved from the State Prosecution Services vide the order read as 2<sup>nd</sup> paper above.

2. Her period of deputation expired on 05.05.2024 AN. As per order read as 4<sup>th</sup> paper above, the deputation of the officers whose sanctioned term expired during the currency of the MCC (ie, from 16.03.2024 to 06.06.2024) was ordered to be treated as extended till 30.06.2024, in relaxation of Rule

140(c), Part I KSR, and they were to be reverted to their parent Department on 30.06.2024, unless the competent authority extended the period of deputation on or before 30.06.2024.

As per the letter read as 5 <sup>th</sup> paper above, the Director of Prosecution requested Government to appoint Smt Leni A Senior Public Prosecutor on deputation basis in National Investigation Agency, New Delhi for an initial period of 3 years. As per letter read as 7th paper above, Smt Leni was reported to have been relieved from Crime Branch vide the proceedings read as 6th paper above and she reported for duty in the Directorate of Prosecution on 19.06.2024 FN.
- 4. Government have examined the matter in detail and are pleased to accord sanction for the deputation of Smt. Leni A, Assistant Public Prosecutor (Senior Grade), as Senior Public Prosecutor in the National Investigation Agency, New Delhi, for a period of three years.
- 5. The Director of Prosecution shall relieve Smt. Leni A from the Prosecution Department accordingly.
