ORDER

The Director, Kerala State Science and Technology Museum, Thiruvananthapuram as per the letter read (1) above, submitted the proposals to the tune of Rs. 7,80,50,000 (Rupees Seven Crore Eighty Lakh and Fifty Thousand Only) for the various plan schemes to be implemented in the Science City, Kottayam by using the funds earmarked in the current year's budget.

- 2. The working group meeting held on 29.05.2024 considered and approved the same.
- 3. In the circumstances, Government are pleased to accord Administrative Sanction for an amount of Rs. 7,80,50,000 (Rupees Seven Crore Eighty Lakh and Fifty Thousand Only) for the implementation of the following plan schemes in the Science City, Kottayam of the Kerala State Science and Technology Museum;
- a. Balance amount to be paid for the Construction of UG sump, OH tank and Food Court -Rs. 75 Lakhs
- b. Balance amount to be paid for the HT/LT Electrification works Rs. 75 Lakhs
- c. Balance amount to be paid for the Construction of Entrance Gate, Exit Gate and Front Compound wall $Rs.\ 26$ Lakhs
- d. Balance amount to be paid for the Construction of Edutainment Components -Rs. 153 Lakhs
- e. Balance amount to be paid to the previous contractor for the development of internal road work-Rs. 16 Lakhs
- f. Installation of the lift and electrical fittings at UG Sump, OH Tank and Food Court Building -Rs. 86.85 Lakhs
- g. Providing external stair case at the UG Sump, OH Tank and Food Court Building Rs. 47.45 Lakhs
- h. Establishment of Astronomical observatory- Rs.82 Lakhs
- i. Providing water connection facility for UG sump and Science Centre Building -Rs.40 Lakhs
- j. Providing streetlights at the side of the Internal Road- Rs.32.20 Lakhs
- k. Development of Walkway from Entrance Plaza to Central Plaza area and landscaping -Rs.147 Lakhs

- 4. The expenditure in this regard will be met from the head of account "2203-00-112-61-36 Grant-in-Aid General Non Salary (Plan) in the current year's budget, subject to the fulfilment of the following conditions.
- 1. The release of funds will be need based, when actual expenditure falls due.
- 2. Adhoc/Advance release of funds before expenditure becoming due will not be allowed.
- 3. The total expenditure will be limited to the Current Year's Budget provision.
- 4. e -tender' system and store Purchase Rules should be strictly followed in all procurements.
- 5. No vehicle can be purchased. A vehicle can be hired if needed. Hiring of vehicles can be done only with the concurrence of Finance Department (G.O (P) No. 66/2018/Fin. Dated, 17.04.2018 and circular No. 85/2018/Fin. Dated, 15.09.2018)
