ORDER

As per Government Order read 1st paper above, Administrative Sanction was accorded for the project 'Conversion of Crafts with Kerosene Engines to Petrol Engines' at an estimated cost of Rs.1000 lakh with Rs.500 lakh as State share and Rs.500 lakh as beneficiary contribution under the Head of Account 2405-00-110-96 (P) and as per Government Order read 2nd paper above, an amount of Rs.100 lakh was released under the Head of Account 2405-00-110-96 (P) towards State share (50% subsidy) of the said project.

- 2) The Director of Fisheries, as per the letter read above has requested for permission to release Rs.88.50 lakh from the Head of Account 2405-00-110-96 (P) to Matsyafed for providing 2nd & final installment state assistance @Rs.25000/- to the 354 beneficiaries under the project 'Conversion of crafts with Kerosene engines to Petrol Engines' and also requested to exempt above Head of Account from Ceiling restriction.
- 3) Government have examined the matter in detail and are pleased to release **Rs.88.50 lakh (Rupees Eighty Eight Lakh Fifty Thousand Only)** under the Head of Account 2405-00-110-96-33 (P) to Matsyafed for providing 2nd & final installment state assistance @ Rs.25,000/- to the 354 beneficiaries under the project 'Conversion of crafts with Kerosene engines to Petrol Engines'.
- 4) The ceiling limit of Head of Account 2405-00-110-96-33 (P) has also enhanced to 88.5% for effecting the release.
