ORDER

As part of this, free legal aid and counselling are also made available to the women. As per the letter read as 1st paper above, the Member Secretary, Kerala Women's Commission had proposed to continue the Disposal of petitions and grievance redressal activities by expending ₹45,00,000/-(Rupees Forty-five Lakh Only) from the Head of Account: 2235-02-103-95-34- OC(P), during 2024-2025. It was also proposed that, 7000 beneficiaries during 2024-2025 will be benefited from this project. The Budget provision under the Head of Account: 2235-02-103-95-34-OC (P), during 2024-2025 is ₹310.00 Lakh.
