### **ORDER**

As per the Government Order read 1st above, Government issued detailed guidelines on the procedure of Bill Discounting system (BDS) for making payment of pending bills of contractors. The bills of Irrigation Department were excluded from the Bill Discounting System and revised schedule of payments was introduced to advance the date of payment as per the Government order read 2nd above. As per GO read 3rd above, Government re-introduced Bill Discounting system in Irrigation department (Major irrigation / Minor irrigation / Irrigation Cauvery Cell-Project-I / Irrigation Project-II / Irrigation Project-III / IDRB / Kuttanadu package) to enable the contractors to avail the BDS facility. The Government declared the schedule date for issuing LoC for clearing the pending bills in respect of Irrigation Department for the month of December 2023 vide Government Order 4<sup>th</sup> above.

Now Government are pleased to sanction the schedule date for issuing LoC for clearing the pending bills in respect of Irrigation Department for the month of January 2024 as detailed below:
