<u>O R D E R</u>

The XVth Finance Commission has recommended an amount of Rs.265 crore as Tied grant for Million Plus Agglomerations for the year 2022-23. Out of this, ₹213.45 crore released from the Union Government was authorized to Urban Agglomerations vide, Government order read as 3rd paper above.

2) The Director, FCD vide, letter read as 4^{th} paper above, has conveyed the release of Undisbursed Grant of Solid Waste Management (SWM) Component of the Million Plus Challenge Fund to other eligible Non-Million Plus cities (NMPCs) as recommended by the 15^{th} Finance Commission for the year 2022-23 amounting to 351.55 crore. It has been requested to transfer the grant-in-aid directly to the Urban Development Department, the Nodal Department for ULBs.

3) Government, after having examined the matter in detail, are pleased to transfer an amount of **₹51,55,00,000/- (Rupees Fifty One crore Fifty Five lakh only**) as Undisbursed Grant of Solid Waste Management Component (SWM)

in FY 2022-23 of the Million Plus Challenge Fund to other eligible Non-Million Plus cities (NMPCs) from the Budget Provision 2023-24 as detailed below:
