ORDER

As per the letter read as 2nd paper above, the State Mission Director, National Health Mission has reported that the state of Kerala has released an amount of Rs.440.20 crores as state share from the current year's budget (Rs.159.24 crores released as balance state share of 2022-23 and Rs.280.96 crores of 2023-24). The state share as per ROP is Rs.550.68 crore and state has released an amount of Rs.280.96 crores only as state share. Hence the NHM has requested to release an amount of Rs.269.72 crores (Rupees Two Hundred and Sixty Nine Crore Seventy Two Lakhs only) from the HoA "2210-06-101-19-02" to the Single Nodal Account of NHM maintained with ICICI bank (Account No.626201074029).

- 2) As per the G.O read as 3rd paper above, Government have authorised additional expenditure to the tune of Rs.40,00,00,000/-(Rupees forty crore only) under the HoA "2210-06-101-19-02" for releasing advance amount from the State share of NHM for 2024-25 for settling various pending claims in respect of the programmes implemented under the National Health Mission.
- 3) Accordingly, Government are pleased to accord sanction for releasing the additionally authorized amount of Rs.40,00,00,000/-(Rupees Forty crore only) under the HoA "2210-06-101-19-02"(State share) (Plan) to the Single Nodal Account of National Health Mission maintained with ICICI bank (Account No.626201074029, IFSC code

ICIC0006262) for settling various claims in respect of the programmes implemented under the National Health Mission.

4) The State Mission Director, National Health Mission shall take timely steps to regularise the additional expenditure through re appropriation of savings only within the Grant before the close of the current financial year.
