ORDER

Comprehensive Administrative Sanction was issued for the CSS "Strengthening & Upgradation of State Govt. Medical Colleges for Increase in PG Seats at Government Medical Colleges, Alappuzha, Ernakulam and Kannur. " wherein an amount of Rs.4.48 crores (Central share of Rs.2.80 crore and State share of Rs.1.68 crore) was sanctioned for the Government Medical College, Ernakulam. An amount of Rs.2,07,00,000 was released as central share for the implementation of the CSS in the three Government Medical Colleges.

As per the G.O read as 2nd paper above, the state share amounting to Rs.138.02 Lakh (Rupees One Crore Thirty Eight Lakh Two Thousand only) was released to the SNA account of DME. Subsequently As per the letter read as 3rd paper above, the Director of Medical Education has forwarded a proposal for according administrative sanction for implementing the project 'Strengthening and upgradation of State Govt. Medical Colleges for increase in PG seats. Phase - II" - at Govt. Medical

College, Ernakulam' with an estimated cost of Rs.70,00,000/- (Rupees Seventy Lakhs only) which is 25% of the central share of Rs. 1.68 crore-42 lakh and 25% of the state share of Rs. 1.12 crore - 28 lakh taken together.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for utilization of fund for an amount of Rs.70,00,000/- (Rupees Seventy Lakhs only) for Strengthening and upgradation of State Govt. Medical Colleges for increase in PG seats Phase - II" at Govt. Medical College, Ernakulam as detailed below;
