**ORDER**

The Government employees who undergo heart surgery are eligible for Special Casual leave under Rule 19, Section II, Appendix VII, Part I, the Kerala Service Rules, for a period not exceeding 45 days in a calendar year on production of certificate to that effect from an authorised Medical Officer.

2. Now a doubt has been raised as to whether the benefit can be extended to those who undergo Pacemaker implantation also.
3. Government have examined the matter in detail and are pleased to order that the Government employees who undergo Pacemaker implantation shall be granted Special Casual Leave upto 21 days subject to the same conditions as under Rule 19, Section II, Appendix VII, Part I, the Kerala Service Rules.
4. However, past cases settled otherwise, if any, will not be re-opened.
5. Necessary amendments to the Kerala Service Rules will be issued separately.


