ORDER

As per the letter read above, the Director of Health Services furnished proposal for construction of new Hospital Building for Community Health Centre, Kesavapuram at an estimated amount of Rs.5.23 crore and requested to accord Administrative Sanction for the same.

2. Government have examined the matter in detail and considering the exigency, **Administrative Sanction is hereby accorded** for the project '**Construction of Hospital Building for Community Health Centre (CHC) Kesavapuram**', in Kilimanoor Block Panchayath for an estimated cost of **Rs.5,23,00,000/- (Rupees Five Crore and Twenty Three Lakh Only)** as per DSR 2018 and 18% GST, by meeting the expenditure under the head of account '**4210-01-110-74-Construction Works under DHS (Plan)**' and subject to the following conditions.

- i. The detailed soil investigation and structural design shall be done before issuing technical sanction. The LS provisions, earmarked in the estimate shall be used for the intended purpose only and detailed estimate shall be prepared before issuing technical sanction.
- ii. There is variation seen in the facilities / area allocated for various purposes in the submitted drawing & estimate report. TS authority

shall finalize the area allocation in consultation with the health department and shall ensure that the built up area shall be used exclusively for hospital facilities only.

- iii. As the existing building, old and newly constructed buildings will have to be demolished, construction of new hospital building seems urgent and inevitable.
- iv. Technical sanction of the building shall be issued only after properly demarcating the balance land after surrender & acquisition/purchase, if required.
