ORDER

Kerala State Civil Supplies Corporation Limited (Supplyco) is procuring paddy on behalf of State Government under Decentralised Paddy Procurement Scheme of Government of India. During the financial year 2021-22, an amount of Rs.525 crores is provided under the head of account “**2408-01-101-96-33 Subsidies (NP)**” in the budget for paddy procurement. As per Government Orders read as 2nd and 5th paper above, an additional authorization for an amount of Rs. 84.8712 Crore (Rs.30.9512 Crore + Rs.53.92 crore) is sanctioned under the said Head of Account.

(2) As per Government Orders 1st and 3rd read above, Government had accorded sanction for an amount of Rs.555.9511279 crore (Rs. 110.14 + Rs. 445.81,11,279) crore to Supplyco towards the payment of State Incentive Bonus to farmers for the period from 2020 December to 2021 May.

(3) As per letter read as 4 th above, the Director of Civil Supplies Department has requested to release an amount of Rs.53.926 crore, (Rs. 41.78 crore + Rs. 4.32 crore + Rs. 4.35 crore + Rs. 3.47 crore) with the interest to farmers towards Supplyco as State Intensive Bonus for the period from 2021 June to September.

(4) Government have examined the proposal in detail and are pleased to accord sanction to release an amount of **Rs.53.926 crore (Rupees Fifty Three Crore Ninety Two Lakh Sixty Thousand only)** from the head of account “**2408-01-101-96-33 Subsidies (NP)**” along with the interest towards Supplyco as State Incentive Bonus for the period from 2021 June to September.

(5) The Director of Civil Supplies will draw and disburse the above amount to Kerala State Civil Supplies Corporation Limited.
