ORDER

As per Government Order read as 1st paper above the Agricultural Insurance Company of India Limited (AICIL) has been selected as the implementing agency of both Pradhan Mantri Fasal Bima Yojana (PMFBY) and Restructured Weather Based Crop Insurance Scheme (RWBCIS) in Kerala for Kharif 2021 and Kharif 2022 seasons.

2. As per Government Orders read as 2nd, 3rd, 4th and 5th papers above, sanction has been accorded to release an amount of Rs. 8,24,00,459/- as first installment, Rs 11,04,38,833.78/- as second installment, Rs 82,23,766/- as third installment and Rs.1,68,370/- as fourth installment respectively of State share of premium subsidy to Agricultural Insurance Company of India Limited towards PMFBY &

RWBCIS for Kharif 2021

3. As per Government Orders read as 6th and 7th papers above, sanction has been accorded to release an amount of Rs. 8,04,92,569/- as first installment and Rs. 21,24,10,985/- as second installment respectively of State share of premium subsidy to Agricultural Insurance Company of India Limited towards PMFBY & RWBCIS for Kharif 2022 season.

As per the letter read as 8th paper above, Director of Agriculture has requested for administrative sanction and release of an amount totaling to Rs.59,10,800/- (Rupees Fifty Nine Lakh Ten Thousand Eight Hundred Only) (Rs. 69617 + Rs. 5841183)as fifth installment for Kharif 2021 & third installment for Kharif 2022 as additional authorization in the head of account 2401-00- 109-65-02 plan under the scheme PMFBY- RWBCIS.

Having examined the matter in detail, Government are pleased to accord sanction for the release and pay of Rs.59,10,800/- (Rupees Fifty Nine Lakh Ten Thousand Eight Hundred Only) for disbursing the amount to the Agriculture Insurance Company of India as fifth installment for Kharif 2021 season & third installment for Kharif 2022 season under the scheme PMFBY & RWBCIS, from the current year's Budget provision available under the head of account 2401-00-109-65-02(plan voted).

6. The Director of Agriculture is authorized to draw and disburse the amount to Agriculture Insurance Company of India Ltd (AICIL) during the current Financial Year.
