### **Abstract**

Home Department – Police Department - State Plan Scheme 2023-24 - Purchase of two wheelers-Supply Order placed for 55 Nos of two wheelers instead of 50 Nos - Ratified - Orders issued.

### **ORDER**

As per Government Order read as 1st paper above, an amount of Rs.50 Lakh has been sanctioned for the purchase of 50 Nos. of two wheelers under the component 'Mobility', under the State Plan Scheme for the year 2023-24. The State Police Chief, as per letter read above, has informed that 55 Nos. of two wheelers can be procured utilising the sanctioned 50 Lakh and accordingly, supply order has been placed for the supply of 55 Nos. of two wheelers for an amount of Rs.50,00,222/-, through GeM Portal, meeting the additional amount of Rs.222/- from the savings amount of Mobility head. The State Police Chief has also informed that there is no additional financial liability to Government in procuring more quantity of two wheelers than sanctioned and it also has operational benefits to the Government as maximum vehicles are needed during election for patrolling and election related duties. The State Police Chief has therefore requested to ratify the action in placing Supply Order for 55 Nos. of two wheelers instead of 50 Nos. sanctioned earlier under the State Plan Scheme for the year 2023-24, without obtaining prior approval of Government.

2) Government have examined the matter in detail and are pleased to ratify the action of the State Police Chief in having placed supply order for 55 nos of two wheelers instead of 50 numbers sanctioned, for an amount of Rs.50 Lakh under State Plan Scheme 2023-24, subject to the condition that the additional 5 two wheelers in excess of the originally

sanctioned number of two wheelers should be in lieu of the replacement of 5 two wheelers as listed below and also on condition that the total expenditure for the purchase of two wheelers has to be limited to the original sanctioned amount of Rs.50 Lakhs.
