ORDER

As per the GO read as 1st paper above, Administrative Sanction was accorded for the installation of transponders in 6000 marine fishing vessels for a total amount of Rs 21.84 crore which includes Rs.13.104 crore central share and Rs.8.736 crore State share.

2) The Director of Fisheries vide letter read as 2nd paper above has requested to :

- a. Revise the Government Order GO(Rt.)No.6/2024/F&P dated 05/01/2024 by including the revised State share as 9.0662333 Crore in accordance with the Corrigendum issued by the Department of Fisheries, Government of India vide letter read as 3rd paper.
- b. To ratify the action taken for releasing the 25% State share of Rs.2.2665583 Crore to the Account of New Space India Limited-PMMSY as directed from GOI so as to utilize the same from the fund sanctioned as Additional Authorisation under the head of

account 2405-00-103-68 (P) from the current years budget provision.

3) Govt have examined the matter in detail and order that the Administrative Sanction issued vide GO(Rt.) No.6/2024/F&P dated 05/01/2024 is revised for the installation of 6000 transponders in marine fishing vessels in Kerala as part of National Rollout plan for installation of vessel communication and support system in marine fishing vessels for Monitoring, Control and Surveillance (MCS) with state share of Rs. 9,06,62,333.3 /- . The action taken by the Director of Fisheries to remit the state share of Rs. 2.2665583 Cr (25% of Rs. 9,06,62,333.3/-) to the a/c of M/s. NSIL is also ratified.
