## **ORDER**

The Director of Handloom and Textiles as per the letter read above submitted a proposal for Modernisation of Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd, Wayanad under the scheme for Modernisation of Integrated Powerloom Societies under TEXFED.

- 2) The Director of Handloom and Textiles has reported that Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society was established as a rehabilitation project, for the Scheduled Tribes and unwed mothers among them and other backward/socially/economically weaker sections of the society, by giving employment for them. It is also reported that for coping up with the changing market trends and to ensure profitability, the Society needs infrastructure upgradation. Thus, the Society proposes to undertake the following modernisation works.
  - Repair and maintenance of pirn winding machine
  - Modernisation of sectional warping machine

- Repair and maintenance of plain looms
- Fixing of Terry mechanism in existing loom
