ORDER

The Director of Handloom and Textiles as per the letter read above has submitted a proposal for Modernisation of Kottayam Integrated Powerloom Industrial Co-operative Society Ltd, Kottayam under the scheme for Modernisation of Integrated Powerloom Societies under TEXTFED.

2)The Director of Handloom and Textiles has reported that upgradation of the looms in Kottayam Integrated Powerloom Industrial Co-operative Society will enable the Society to produce more value added fabrics. It is also reported that the Society proposes to undertake the following modernisation works.

- i. Purchase of Inspection Table with Folding and Meter Counter
- ii. Purchase of Power loom Spare (including modernised shuttle and pirns)
- iii. Purchase of Trolley for Power loom sheds (Beam Trolley and Pirn carrying Trolley)
- iv. Electrical Maintenance work

3) The expected outcome of the proposal is as follows:

- The Inspection Table will increase warehouse production and minimise workers effort.
- Trolley helps the workers to shift cloths, pirns, bales etc and thus reduces work effort.
- Through the electrical maintenance, the break down in the power house /transformer yard and damages of the electrical spares will be minimised.
- Thus more productivity can be achieved.

8) Government have examined the recommendation of the Working Group and are pleased to accord Administrative Sanction for the proposal for Modernisation of Kottayam Integrated Power loom Industrial Co-operative Society Ltd under the scheme for Modernisation of Integrated Power loom Societies (under TEXTFED) for an amount of Rs.10,00,000/-(Rupees Ten lakh only) debiting the expenditure under the head of account 4860-01-195-92(P) from the current year's budget provision.
