**ORDER**

As per Government Order read as 1st paper above, M/s Kerala Minerals & Metals Limited, Chavara, Kollam was granted a mining lease for mining Beach Sand Minerals from an area of 203.802 Hectares of land in Karunagappally Taluk, Kollam District for a period of 20 years, subject to certain conditions. As per Government Orders read as 2nd to 12th papers above, the time limit for execution of mining lease was extended up to 23.04.2024. The company as per letter read as 13th paper above has informed that more time is required for obtaining CRZ recommendations from KCZMA, hence the company has requested to extend the time limit for execution of

mining lease deed for a period of one year w.e.f 24.04.2024. As per the letter read as 14th above, the Director of Mining & Geology has recommended Government to extend the time limit for execution of mining lease deed in respect of mining lease granted to M/s KMML for a period of one year.

2.Government have examined the matter in detail and are pleased to accord sanction for the execution of time limit for execution of mining lease deed in respect of mining lease granted to M/s Kerala Minerals & Metals Limited, Chavara, Kollam from an area of 203.802 hectares of land in Krunagapally taluk, Kollam district for a further period of one year from w.e.f 24.04.2024 subject to the condition that M/s KMML has to obtain all required statutory licenses/clearance within the extended period.
