ORDER

Government of Kerala vide Government Order read as 1st paper above has adopted the vehicle scrappage policy of Government of India which insisted scrapping all Government owned vehicles which are older than 15 years at registered vehicle scrapping facility and to grant motor vehicle tax concession on new vehicles registered.

Government vide Government Order read 2 nd above accorded sanction to Mission Director, State Horticulture Mission, Kerala to condemn the scrappage norm surpassed vehicles and to purchase new vehicles in place of such vehicles using fund under the Head - Institutional Strengthening under MIDH funds for the financial year

2023-24 in the name of Principal Secretary, Department of Agriculture, Government of Kerala.

3. Mission Director, State Horticulture Mission-Kerala vide proposal read as 3rd paper above requested for Government sanction to purchase vehicles through Direct Purchase from GeM Portal in the name of Principal Secretary, Department of Agriculture, Government of Kerala.

Having examined the matter in detail, Government are pleased to accord sanction for the purchase of 1 Toyota Innova Crysta G7 Seater Avant Garde Bronze colour utility vehicle expending Rs. 18,63,024/- (Rupees Eighteen Lakh Sixty Three Thousand Twenty Four Only) and 5 Mahindra Bolero-B6 BS6-Diesel vehicle expending Rs.44,41,140/- (Rupees Forty Four Lakh Forty One Thousand One Hundred Forty) through Direct Purchase from GeM Portal using fund under the Head - "Institutional Strengthening under MIDH funds for the financial year 2023-24" in the name of Principal Secretary, Department of Agriculture, Government of Kerala.
