## **ORDER**

Government Order read as 1<sup>st</sup> paper above Administrative Sanction was accorded to the Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd, for Skill & Entrepreneurial Development Programme (2023-24) at an estimated cost of Rs.350 lakh, meeting the expenditure from the head of account '2235-02-190-97-34-OC(Plan)' provided in the current year's budget. As per paper read as 2<sup>nd</sup> & 3<sup>rd</sup> above an amount of Rs.185.5 Lakh were released to MD,KSWCFC as two Instalment for the implementation of the Scheme.

As per letter read as 4<sup>th</sup> paper above, the Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd has requested to release an amount of Rs.164.5 Lakh for disbursing capital subsidy to the remaining selected beneficiaries for the year 2022-23 & 2023-24 under Skill & Entrepreneurial Development Programme.

Government have examined the matter in detail and are pleased to release Rs.42 Lakh (forty two Lakh rupees only) as third instalment to Kerala State Welfare Corporation for Forward Communities Ltd under the head of account '2235-02-190-97-34-OC(Plan)' for disbursing capital subsidy to the remaining selected beneficiaries for the year 2022-23 & 2023-24 under Skill & Entrepreneurial Development Programme subject to the terms and conditions mentioned below.

- \* The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
- The instructions in Circular No.84/2008/Fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.

\* Managing Director, KSWCFC Ltd shall furnish duly authenticated detailed component wise statement of Expenditure and Utilization Certificate in the prescribed form as appended to the GO(MS)No.4/2020/Fin dated 09.01.2020.

If there is un-utilized amount at the end of this financial year that should be refunded

to the Government during the financial year itself.
