ORDER

As per the G.O read as 2nd paper above, an amount of Rs. Rs.20,39,33,000/- (Rupees Twenty Crore Thirty Nine lakh Thirty Three Thousand only), was released as matching State share of Kind grant during the period 2023-24. Now as per the letter read as 3rd paper above, the NHM has informed that the Government of India has released 8599.35 lakhs kind grant for various programmes under NHM and the state of Kerala has released the corresponding state share for the first three quarters and hence has requested to release the matching state share of Rs.1361.40 lakhs in proportion to the 4th quarter release of 2042.10 lakhs by the GOI from the HoA "2210-06-101-19 (02)" to the SNA account (ICICI Bank account No.626201074029, IFSC ICIC0006262) of State Health & Family Welfare Society (NHM).

2) Government have examined the matter in detail and are pleased to release an amount of Rs.13,61,40,000 (Rupees Thirteen Crore Sixty One Lakh and Forty Thousand only), the matching State share of Kind grant during the FY 2023-24 (4th quarter) from the budget provision

under the h/a "2210-06-101-19-02(Plan)" during the FY 2024-25 to the SNA account (ICICI Bank account No.626201074029, IFSC ICIC0006262) of State Health & Family Welfare Society (NHM).

3) The State Mission Director, National Health Mission shall furnish Utilisation Certificate in this regard to Government.
