ORDER

Government have accorded administrative sanction for an amount of Rs.96,00,00,000/- (Rupees Ninety Six Crore Only) towards constructing housing for police personnel above or as part of the following police stations under the Scheme 'Special Assistance to States for Capital Investment 2023-24'. As a part of implementing this Scheme, Government of India has informed that Rs.48 Crore will be released as 1st installment and the second installment of remaining 50% will be released by Government of India based on the progress made in the utilisation of 1st installment on or before 31 March 2024.

- 2. As per Government order read as 2nd paper above, an amount of Rs.48Crore is additionally authorised under the Head of Account '4055-00-211-96-Housing for police personnel or as part of Police Stations in urban areas (PV)', to transfer credit the first installment to the bank account of the Nodal Agency of the scheme 'Special Assistance to States for Capital Investment for the Year 2023-24', for increasing the housing facility for the Police personnel and their families in Urban Areas. The State Police Chief as per letter read above has requested to issue release order for transferring the amount of Rs.48Crore to the respective Single Nodal Account(SNA) for expenditure via PFMS.
- 3. Government have examined the matter in detail and are pleased to accord sanction for transferring an amount of Rs.48,00,00,000/- (Rupees Forty Eight Crore Only) under the head of account '4055-00-211-96-Housing for

police personnel or as part of Police Stations in urban areas (PV)' to the SNA Account 42720411272 opened in SBI Althara Branch, Thiruvananthapuram (IFSC-SBIN0007203) under the scheme 'Special Assistance to States for Capital Investment for the Year 2023-24'.

4. The SNA Officer shall adhere to the guidelines and instructions issued by the Central Ministry and Government concerned from time to time.
