ORDER

Vide letter referred as 4th paper above, Chief Engineer, IDRB has informed that, the total amount payable to the Arbitration Tribunal as Arbitration fee in Case DRIP/R1/CHIMONI/IP/2020 in DRIP related work in Chimoni dam is ₹7,50,000/- of which 50% share , ie a sum of ₹3,75,000/- {including the reading fee and the arbitration fee for 4 sittings for 3 arbitrators {50% of [3x50,000+(3x4x50,000)]} shall be paid by Claimant and remaining 50% by the Respondent. As per the Award read as 1st paper above, Claimant's (Department) share of the Arbitrator's fee inclusive of the Respondent's share has been paid by the respondent (Contractor). The Award also stipulates that shall be realized by the respondent from the claimants towards the payment of Claimant's

share of fees. The Chief Engineer (I&D) as per letter read as 3rd and 4th papers above has requested for sanction of payment of ₹3,75,000/- to pay 50% share of the total fee in the Arbitration Case DRIP/R1/CHIMONI/IP/2020 in DRIP work in Chimoni dam.

Government have examined the matter in detail and pleased to accord sanction to the Claimant for the payment of ₹Rs.3,75,000/-including the reading fee and the arbitration fee for 4 sittings for 3 arbitrators {50% of [3x50,000+(3x4x50,000)]} in the Arbitration Case DRIP/R1/CHIMONI/IP/2020 (Case-III) in DRIP related work in Chimoni dam.
