As per the G.O read as 1st paper above, Government have released an amount of Rs.1302.09 Lakh the matching State share of Kind grant during the period 2023-24. As per the G.O read as 2nd paper above, Government have released an amount of Rs.1030.08 Lakhs (Rupees Ten Crore Thirty lakhs Eight Thousand only), the matching State share of Kind grant during the period 2023-24. As per the letter read as 3rd paper above, the SMD, NHM has reported that the Government of India has released an amount of Rs.3058.99 lakhs as kind grant for the financial year 2023-24 and hence has requested to release the corresponding state share of Rs.2039.33 lakhs.
