ORDER

There is a need for comprehensive awareness creation and sensitization of the NRK community and the returnees about the schemes and activities of NORKA Department and also to make them aware of safe migration for obtaining gainful employment. The job seekers are to be sensitized about illegal recruitment, visa cheating, destination country's cultural, legal and heritage matters by making use of new media apart from the conventional media. Pre-departure Orientation Programme is also conducted in big cities in India where there is considerable population of Keralites.

- 2. In the current financial year's budget, an amount of Rs.100,00,000/- (Rupees One Hundred Lakh only) has been provided for the scheme 'Awareness campaign on illegal recruitment and visa cheating including Pre-Departure Orientation Programme' under the Head of Account 2230-01-103-47 (Plan).
- 3. The Departmental Working Group meeting held on 03.06.2024 has approved the proposal submitted by the Chief Executive Officer, Norka-Roots at a total cost of Rs.100,00,000/- (Rupees One Hundred Lakh only) for the scheme.
