ORDER

As per the Government order read as 1 st paper above, sanction was accorded for the recruitment of various posts on contract basis in KSDMA for the conduct of the LSG DM Plan preparation, as part of "Nammal Namukkayi Campaign" of RKI. The posts were supported financially from Rebuild Kerala Initiative for one year from the date of joining of the recruited staff.
