- ь. Rs. 20 lakhs each to all districts for Flood Exgratia -SDRF Response and Relief Window (Fatality and Injuries as per norms)
- c. Rs. 50 lakhs each to all districts for immediate restoration (Geotube, Geobags, temporary measures etc. as in Orange Book) SDRF Recovery and Reconstruction Window.
- d. Rs.1 Crore each to DDMA Thiruvananthapuram (for use in Thiruvananthapuram City), DDMA Kozhikode (for use in Kozhikode City), and DDMA Ernakulam (for use in Kochi City) for preparedness to urban flooding- SDRF Preparedness Window.

In this circumstances, Government are pleased to release the assistance as follows;

i. Rs.1Crore each to the District Collectors from the head of account 2245-02-101-94 -01 F-Other items for monsoon preparedness

activities (preparedness measures- camps, advances etc as in Orange Book)

- ii. Rs.10 lakh each from the head of account 2245-02-800-96-F-Exgratia to injured persons and Rs.10 lakh each from the head of account 2245-02-111-99 F-Exgratia to bereaved families to all District Collectors.
- iii. Rs. 50 Lakh each to all District Collectors from the head of account 2245-02-101-94 -01 F-Other items, for immediate restoration (Geotube, Geobags, temporary measures etc.. as in Orange Book).
- iv. Rs.1 Crore each to DDMA Thiruvananthapuram (for use in Thiruvananthapuram City), DDMA Kozhikode from the head of account 2245-02-101-94 -01 F-Other items (for use in Kozhikode City), and DDMA Ernakulam for preparedness to urban flooding (for use in Kochi City).

The amount should be utilized from the current years budget provision, subject to the condition laid down in the SDRF norms. The expenditure details in this regard should be uploaded in the NDMIS portal within a month of the expenditure.
