ORDER

The Director of Handloom and Textiles as per the letter read above has submitted a proposal for Modernisation of Neyyattinkara Taluk Integrated Powerloom Industrial Co-operative Society Ltd, Thiruvananthapuram under the scheme for Modernisation of Integrated Power loom Societies under TEXFED.

- 2) The Director of Handloom and Textiles has reported that the Mill was established with the objective to rehabilitate the hooch traders of Neyyattinkara Taluk who have voluntarily stopped the illegal activity. The renovation works are progressing in the Society and the Mill proposes to restart 40 more looms and the production. Hence, the Society proposes to undertake the following works as part of the modernisation project.
 - Repair and maintenance of 40 looms
 - Providing power connection (Electrical cable, switch boards and accessories)

- 6)The Departmental Working Group Meeting of Industries Department held on 29/05/2024 considered the proposal for Modernisation of Neyyattinkara Taluk Integrated Powerloom Industrial Co-operative Society Ltd under the scheme for Modernisation of Integrated Powerloom Societies(under TEXFED) and recommended for issuing Administrative Sanction for an amount of Rs. 15 lakh for the proposal.
