ORDER

The Budget allocation for Pradhanmantri Jan Arogya Yojana/ Karunya Arogya Suraksha Padhathi for the financial year 2024-25 is Rs.5,46,54,00,000/- (Rs.546.54 crore) under head of account 2210-06-800-81 and Rs.1,32,00,00,000/- (Rs.132 crore) under head of account 2210-06-800-80.

As per the Government Order read as 1st paper above, an amount of Rs.119 Crore has been sanctioned from the head of account "2210-06-800-81-PMJAY/KASP-State scheme(Plan) and as per the Government Order read as 2nd paper above, an amount of Rs.100 Crore from the budget provision under the head of account "2210-06-800-81(Plan)" and an amount of Rs.50 Crore from the budget provision under the head of account "2210-06-800-80-02(Plan)" for the financial current year SO as to

the outstanding dues to the hospitals empaneled under PMJAY-KASP Scheme.

- 3. As per the letter read as 3rd paper above the Executive Director, State Health Agency, has requested Government to release an amount of Rs 100 Crore to the escrow account of State Health Agency.
- 4. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.100 crores to the State Health Agency [Rs.50 Crore from the CFY budget provision under the h/a '2210-06-800-81-Plan' and an amount of Rs.50 Crore from the CFY budget provision under the h/a '2210-06-800-80-02-Plan'] so as to settle the outstanding dues to the hospitals empaneled under PMJAY-KASP Scheme to the escrow bank account mentioned below.
