The Director, Directorate of Industries and Commerce has submitted a project proposal for the scheme "Revival of Small and Medium Scale Cashew Factory Units" for an amount of ₹ 200 lakh (Rupees Two Hundred Lakh only) to be met from the current years' budget provision under the H/A 2852-08-600-79 for the Financial Year 2024-25.

The Scheme is envisaged for assistance of Capital Grants to Small and Medium Cashew Factory Units which intends to make the Cashew Factories in Kerala more competitive by partial modernization and thereby improving their productivity and turnover substantially. The assistance also includes interest subvention to cashew factories for the loans taken from financial institutions for their working capital needs to make the Cashew Factories in Kerala sustainable and more competitive by availing sufficient Working Capital and thereby they shall be able to provide employment to the workers who lost their livelihood.
