## <u>ORDER</u>

As per the Government Order read as  $1^{st}$  paper above, Government have accorded administrative sanction for the appointment of a consultant under Export Promotion in the Annual Plan 2022-23 for Vegetable Development Support to VFPCK. Further, as per the Government Order read as  $2^{nd}$  paper above, Government have accorded sanction to appoint a consultant in VFPCK, initially for a period of six months, under the terms and conditions proposed by the Chief Executive Officer, VFPCK.

As per the letters read as  $3^{rd}$  above, the Chief Executive Officer, VFPCK has informed that the tenure of the consultant appointed as per Government Order read as  $2^{nd}$  paper above has already expired on 09.10.2023 and presently, there is no consultant working in VFPCK. Therefore, the Chief Executive Officer has informed that the service of a consultant for one year shall be helpful in promoting exports in a targetted and efficient manner, and fresh recruitment of Consultant for Agri Export Promotion would be ideal and Expression of Interest can

be invited for the same. He has also furnished the detailed proposal including scope of work of Consultant for Agri Export Promotion etc and has informed that the appointment of consultant on contract basis was envisaged as scheme implementation support and approvals were received as per the above Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> papers above.

Government have examined the matter in detail and are pleased to accord sanction to appoint a consultant in VFPCK for a period of six months , under the terms and conditions proposed by the Chief Executive Officer, VFPCK ,at no cost to Government and by giving preference to the retired officials from Customs, DGFT etc.
