**ORDER**

As per the G.O read as 1<sup>st</sup> paper above, an amount of Rs .20,39,33,000/- (Rupees Twenty Crore Thirty Nine lakh Thirty Three Thousand only), was released as matching State share of Kind grant during the period 2023-24. As per the G.O read as 2<sup>nd</sup> paper above, Rs.10 crores was sanctioned to NHM for the payment of ASHA incentives for the month of January 2024. Both the funds could not be drawn in the FY 2023-24 due to the restrictions for submitting bills. Hence as per the letter read as 3<sup>rd</sup> paper above, NHM has requested to revalidate both the Government orders so as to draw the amount from the budget provision for the financial year 2024-25 and to release the amount to the SNA account of NHM.

2) Government have examined the matter in detail and are pleased to revalidate the Government orders read as 1<sup>st</sup> and 2<sup>nd</sup> paper above to enable the National Health Mission to withdraw Rs.30,39,33,000/- (for the disbursement of matching State share of Kind grant during 2023-24 and for the payment of ASHA incentives for the month of January 2024) from the budget provision under the head of account "2210-06-101-19(02)-(Plan)" during the FY 2024-25 and to release the amount to the SNA account of National Health Mission maintained with ICICI bank (Account No.626201074029).
