### ORDER

Government have accorded administrative sanction for an amount of Rs.110.33 Lakh under the Head of Account "2055-00-115-98-43" for the procurement of Training and Infrastructure Facilities for Special Operation Group (SOG) under the scheme Anti-Terrorist Squad (ATS) under State Plan Scheme 2023-24 as per Government Order read above. The State Police Chief as per letter read above has informed that the Superintendent of Police, Special Operation Group has reported that, being progressively taking the procurement procedures for implementing the above said scheme through GeM Portal, after procuring some of the items and supply orders issued to the remaining, there is a possibility of having savings for Rs.6.5 Lakhs and the amount allotted for procuring 05 Nos. of Battery Charger, under the component 'Training Equipment' is Rs.5000/- which is insufficient, as in GeM bidding the unit cost of the Battery Charger in the appropriate specification amounts to Rs.4000/-. Therefore an additional amount of Rs.20,000/- is required for procuring

05 Nos. of Battery Charger in the appropriate specification for Special Operation Group.

2) Further the State Police Chief has also informed that an amount of Rs.13.35 Lakhs has been sanctioned for procuring 03 Nos. of Passive Night Vision Goggle (PNVG) for special Operation Group as per Government Order read above. Now the SP, Special Operation Group informed that, procuring Passive Night Vision Goggle (PNVG) in appropriate specification at this quantity is not enough. Hence it is suggested that, an amount of Rs.13.35 Lakhs already sanctioned for procuring 03 Nos. Passive Night Vision Goggle (PNVG) may be combined to the savings amount above said for procuring additional quantity of Passive Night Vision Goggle (PNVG) so as to cater the deficiency of the items for Special Operation Group.

3) The State Police Chief has therefore requested to accord revised administrative sanction for the additionally required amount of Rs.20,000/- for the component 'Training Equipment' for procuring 05 Nos. of Battery Charger in the appropriate specification from the savings amount and also to accord revised sanction to utilise the remaining savings amount of Rs.6.3 Lakhs for procuring maximum quantity of Passive Night Vision Goggle (PNVG) which are inevitable for Special Operation Group.

4) Government have examined the matter in detail and are pleased to accord revised administrative sanction for the purchase of 5 Nos. of battery charger in the appropriate specification for an amount of Rs.25,000/- (Rupees Twenty Five Thousand Only) by meeting the expenditure under the head of account "2055-00-115-98-43" instead of

Rs.5,000/- sanctioned as per Government Order read above. The State Police Chief shall not increase the sanctioned quantity of Passive Night Vision Goggle (PNVG).

5) The Government Order read above stands modified to the above extent only.
