ORDER

WHEREAS, it has been disclosed from the records of investigation in CB Crime No.657/CB CU-III/KKD/12 that the accused [A1] Unidentified, falsely implicated his name and address as Mohammed Haris Erali Paramba, S/o Abdulla Haji, H No.26/205, Fathima Manzil, Karuvalam P O, Padannakkad, Kasaragod and had obtained Indian Passport bearing No.H 9687402 by submitting passport application in a fake name and address along with forged connected documents such as election ID Card, Extract of School Admission Register of CMC Boys School, Elathur and fraudulently obtained Passport bearing Number U 686770 before Regional Passport

Office, Kozhikode as original with the knowledge and assistance of the accused persons [A2] Ashokan V, S/o Kunhiraman V, Keerthi Nivas, Pudukai P O, Neeleswar Via, Hosdurg, Kasaragod, [A3] E P Chandran, S/o Krishnan K V, Edadan Puthiya Veedu, Muthathi, Koram P O, Payyannur, Alapadamba, Mathil, Kannur & [A4] Sathyan M, S/o Narayanan P, Near ALP School, Avikara, Hosdurg, Kanhangad P O, Kasaragod. The accused persons [A2] and [A3] prepared a fake passport enquiry report and forwarded it to higher authorities with a fake signature. Thus the accused persons [A2] & [A3] had committed offences intentionally by forging the Passport Verification Report and cheated the Government and abetted for the commission of offences of the accused [A1] and in furtherance of the common intention worked together to obtain the Indian Passport to the accused [A1] and thus cheated the authorities and is there by punishable under sections 420, 465, 468, 471, 120 B r/w 34 of Indian Penal Code, 1860 and section 12 (2) of Passport Act, 1967 and the accused [A4] Sathyan M delivered the Passport to the accused [A1] in fake address and had committed offences intentionally and is there by punishable under sections 420, 120 B r/w 34 of Indian Penal Code, 1860 and section 12 (2) of Passport Act, 1967.

AND WHEREAS, the Government of Kerala after careful examination of the records of investigation in CB Crime No.657/CB CU-III KKD/12 are fully satisfied that the aforesaid accused persons, [A2] Ashokan V, [A3] E P Chandran & [A4] Sathyan M committed offences punishable under section 12(2) of Passport Act, 1967 along with other offences for which they should be prosecuted.

AND WHEREAS, Department of Posts, Government of India, as per the order read as 2nd paper above have accorded sanction under section 218 of BNSS 2023 for prosecuting the accused [A4] Sathyan M, under criminal law.

AND WHEREAS, Government of Kerala as per order read as 3rd paper above have accorded sanction under section 218 of BNSS 2023 for prosecuting the accused persons [A2] Ashokan V & [A3] E P Chandran, under criminal law.

NOW THEREFORE, Government of Kerala, in exercise of the powers conferred by section 15 of the Passports Act, 1967 read with Government of India notification No. GSR 662(E), dated 01.12.1979 of the Ministry of External Affairs do hereby, accord sanction to prosecute the aforesaid accused persons [A2] Ashokan V, [A3] E P Chandran & [A4] Sathyan M, for the offences punishable under section 12(2) of the Passports Act, 1967, in Crime No.657/CB CU-III/KKD/12 and for taking cognizance of the said offences by a court of competent jurisdiction.
